In 2015, Port Waratah conducted a Diversity Study in which we interviewed a cross-section of employees about their perceptions of diversity and inclusiveness. Building on this, during our Community Attitude Survey in 2016, 43.2% of community respondents indicated diversity was an extremely important issue.

Port Waratah began its journey towards a more diverse and inclusive workplace in 2016 by developing a Diversity and Inclusion strategy and policy. We have a strong record of non-discrimination, but we acknowledge that we have too few women in leadership roles.

Our Diversity and Inclusion Strategy aims to improve our knowledge base and understanding, increase our commitment and involvement, and leverage our existing policies and awareness. Launched in April 2016, it was developed based on feedback from employees and our community.

We also formed a Diversity and Inclusion Working Group that meets on a bi-monthly basis, consisting of six (6) female employees or 43% and eight (8) male employees or 57%. Our management team and the Working Group participated in unconscious bias training sessions facilitated by an external Diversity and Inclusion consultant. In 2017 Port Waratah will implement further active opportunities for employee involvement in diversity and inclusion initiatives and will measure and monitor progress.

In 2016 four (4) of our female employees took part in the WIMnet NSW Mentoring Programme. Established in 2015, it is the first and only face-to-face mentoring programme for women working in the NSW resources sector. The programme matches mentees and mentors with the help of Registered Psychologists, and conducts career guidance training and workshops. The programme was highly valued by all participants and we will continue our support of it next year.

Trained female co-facilitators lead four (4) What's Next business improvement initiatives during the period. The What's Next initiatives take teams of employees from across the business to design and implement business solutions.

Three (3) or 10% of our female staff employees utilised Flexible Working Arrangements during the reporting period. One (1) female employee commenced a new FWA during the period, one (1) existing arrangement was varied per the female employees request, and one (1) FWA was temporarily suspended whilst the employee performed higher duties.

One (1) or 50% of our female Enterprise Agreement (EA) employee utilised an Individual Flexibility Arrangement on her return from Parental Leave.

In addition, during the reporting period one (1) additional female employee applied and was approved for an FWA to commence in the next reporting period.

One (1) male employee concluded an FWA during the period, and one (1) additional male employee applied for, was approved and completed his FWA. Male utilisation of FWA's was less than 1%.

Four (4) female employees accepted secondment opportunities in other departments during the reporting period, one (1) of which was performing higher duties in a leadership role.

Each year Port Waratah provides two (2) local university students with scholarships for the duration of their degree program. For 2016-2017 Port Waratah was pleased to provide scholarships to two (2) new female students studying in STEM fields. Five (5) female and three (3) male scholarship students were offered paid work experience in addition to their annual bursary.

Domestic violence is an issue that Port Waratah takes very seriously for both our employees and our local community. After a number of years of ongoing support, Port Waratah has stepped up our financial contribution to Jenny's Place. Their Newcastle Domestic Violence Resource Centre provides counselling, information, safety and escape planning, advocacy, and referral services to women and children who are escaping domestic and family violence or homelessness.

The partnership commencing in the 2016-2017 reporting period will provide \$160,000 in funding and an increased capacity for Jenny's Place to develop strategies and plans to transition to a more sustainable future funding model, and increase staffing levels. At present, the Resource Centre does not receive any government funding, and relies entirely on community donations, small grants, and fundraising.


